#### **OUTREACH GRIEF SUPPORT**

Good morning, Friends. As I write this column during the first part of February for the March Newsletter, it is cold, and there is snow everywhere. It reminds me of an article, "Snowflakes," written by Darcie Sims (nationally certified thanatologist) for TAPS Magazine for Dec 21, 2008, if you would like to read the complete article.

Have you ever thought about a snowflake? Each snowflake is a completely different design and pattern. No two are ever created exactly the same. It's a mystery. There are very few things that can be so lovely, so delicate, so perfect, so different ... and disappear so quickly, never to be reproduced in the same pattern again.

Sometimes it seems as though people are like that ... and they disappear too quickly, too.

Each of us is as unique as a snowflake. We each have a unique look, sound, smell, touch. We are cut from unique patterns, assembled in an endless variety of shapes, styles, and combinations. There are no identical matches, just as there are no identical snowflakes.

We know this, but when it comes to grieving, sometimes we think that everyone should grieve the same way. Some of us will talk our way through the iciness of our grief, while others prefer more solitude. Some want to read everything they can about grief, while others wish to submerge themselves in work. Some cry endlessly, while others never shed tears. We are as unique as snowflakes drifting from the sky.

There is no right or wrong way to grieve. Just as snowflakes find their way to their destination, so, too, will each of us find our own way through grief. Frozen hearts and numb minds do eventually thaw. Icy memories that chill to the bone can grow warmer as we begin to move through our grief.

Whatever hurt we are carrying ultimately becomes a part of our history. We become the sum total of all of our experiences. These hurts leave scars, some big, some small, but all are significant in their pain. If we begin as frozen beings, the journey through grief becomes a process of thawing. So, be patient with yourself this winter season. Recognize your own unique emotions and hurts. You will survive this winter season. You will begin to defrost eventually, so cherish your differences rather than use them as a yardstick of judgement.

## Donating to a Charity Using a Qualified Charitable Distribution (QCD) (Information from Fidelity Investments Website)

If you are age 72 or older, IRS rules require you to take Required Minimum Distributions (RMD) each year from your tax-deferred retirement accounts. This distribution is considered taxable income. You can reduce your taxes if you are required to make an RMD from a Traditional IRA, and you make charitable contributions anyway, by making a Qualified Charitable Distribution (QCD). You can take advantage of this option even if you take the standard deduction.

#### The rules of QCDs. A QCD must adhere to the following requirements:

- You must be at least 70½ years old at the time you request a QCD. If you process a distribution prior to reaching age 70½, the distribution will be treated as taxable income.
- For a QCD to count toward your current year's RMD, the funds must come out of your IRA by your RMD deadline, which is generally December 31 each year.
- Funds must be transferred directly from your IRA custodian to the qualified charity. This is accomplished by
  requesting your IRA custodian issue a check from your IRA payable to the charity. You can then request that the
  check be mailed to the charity or forward the check to the charity yourself.
  Note: If a distribution check is made payable to you, the distribution would NOT qualify as a QCD and would be
  - treated as taxable income.
- The maximum annual distribution amount that can qualify for a QCD is \$100,000. This limit would apply to the sum of QCDs made to one or more charities in a calendar year. If you're a joint tax filer, both you and your spouse can make a \$100,000 QCD from your own IRAs.
- The account types that are eligible for QCDs include:
  - Traditional IRAs
  - o Inherited IRAs
  - SEP IRA (inactive plans only\*)
  - SIMPLE IRA (inactive plans only\*)
- Under certain circumstances, QCDs may be made from a Roth IRA. Roth IRAs are not subject to RMDs during your lifetime, and distributions are generally tax-free. Consult a tax advisor to determine if making a QCD from a Roth is appropriate for your situation.
- Certain charities are not eligible to receive QCDs, including donor-advised funds, private foundations, and supporting
  organizations. You are not allowed to receive any benefit in return for your charitable donation. For example, if your
  donation covers your cost of playing in a charitable golf tournament, your gift will not qualify as a QCD.
- Contributing to an IRA may result in a reduction of the QCD amount you can deduct. \*

#### Tax filing for QCDs

A QCD is reported by your IRA custodian as a normal distribution on IRS Form 1099-R for any non-Inherited IRAs. For Inherited IRAs or Inherited Roth IRAs, the QCD will be reported as a death distribution. You should keep an acknowledgement of the donation from the charity for your tax records. Please consult a tax advisor to learn more.

For a better understanding of how QCDs can affect your taxable income, let's consider a few hypothetical scenarios. Ron has been taking RMDs for the past few years, but this year he has decided to make a QCD. Ron did not make any non-deductible contributions to his IRA, so all of his distributions would be taxable:

Security 1. Box takes a position of his annual RMD as a OCD
